The regular scheduled meeting of the Crete Township Board of Trustees was called to order by Supervisor Liccar at the Crete Town Hall at 7:00 p.m.

APPROVAL OF BILLS: Motion to approve the minutes of the July 12, 2017 Board of Trustees meeting was made by Trustee Piacentini, seconded by Trustee Hodge. Minutes stand approved as written.

REPORTS:

SUPERVISOR – Supervisor Liccar gave an update of the Intermodal Relations Committee with the following information:

. The property has been purchased but no plans are currently in play. They have made an offer to donate property for green space for citizens to be able to use, but Crete Township Officials have suggested the donation be made to the Will County Forest Preserves, since they have the expertise to design and maintain the property for that purpose.

. A request for a contribution to SSSRA for Crete Township residents with disabilities to participate in program activities. Motion to approve the donation of \$1,210.00 was made by Trustee Elton, seconded by Trustee Hodge. . Supervisor Liccar explain the deficit in the IMRF contributions that showed up in the current audit.
