Crete Township Board of Trustees Meeting March 8, 2017

Supervisor Liccar called the regular scheduled meeting of the Crete Township Board of Trustees to order at 7:00 p.m. at the Crete Town Hall. Trustees in attendance were: Elton, Grady, Hodge and Piacentini. There was a quorum present.

Supervisor Liccar than gave an update for the proposed CSX intermodal. He stated a committee has been formed, with representation from township residents to open lines of communication of facts related to the facility. Supervisor Liccar than accepted the addition of a representative of the President of the Homeowners Association from the area affected.

Supervisor Liccar than requested approval of a quote from Aquarius Networks to perform general office updates. Motion to approve was made by Trustee Elton, seconded by Trustee Hodge. Roll call was taken as follows: Trustee Elton – yes, Trustee Grady – yes, Trustee Hodge – yes, Trustee Piacentini – yes, Supervisor Liccar – yes.

Supervisor Liccar requested board approval to add Kathie Holubek (clerk) as an additional signer on township bank accounts for emergency purposes. He stated in the recent past, when Supervisor Most was hospitalized, and not available for signature on checks, it posed a delay in bill payments. This addition would not let this happen again. This additional signature would only be needed in cases of emergency, Supervisor Liccar has full authority for signatures on all banking transactions, including check signing.

Supervisor Liccar than explained the building usage policies with regards to a charge being levied or waived for cleanup or additional services when using Town hall for evening meeting.

Clerk Holubek requested approval of the agenda set for the Annual Town Meeting to be held on April 11, 2017. Motion to approve the agenda as submitted was made by Trustee Piacentini, seconded by Trustee Hodge. Motion to allow Trustee Grady to purchase this insurance was made by Trustee Piacentini, seconded by Trustee Elton. A building usage request was submitted by Laurie Summers, Citizens Advisory for Regional Infrastructure District 1 for additional dates as amended. Motion to approve this request was made by Trustee Elton, seconded by Trustee Hodge. Motion also included waiving of fees.

A request for bid letting for law maintenance and snow plowing was discussed and table due to a conflict with the last agreement signed for either 1 or 2 years. After checking with the office files, last agreement was signed for a 2 year term, therefore not necessary to re-bid at this time.

A request was received from the Crete F Men for a donation for the Easter Egg Hunt this year. Motion to send a donation was made by Trustee Elton seconded by Trustee Piacentini. Roll call was taken as follows: Trustee Elton – yes, Trustee Grady – yes, Trustee Hodge – yes, Trustee Piacentini – yes.
